RULES AND REGULATIONS

1. Proper tennis attire must be worn at all times. No black sole sneakers allowed.
2. Group captains will be responsible for collection of all payments and for supplying the club with a list of the players in the group before the start of the season.
3. Full payment must be paid on or before December 19, 2024. All unpaid balances after this date will be charged a late fee of 1 ½ % per month. If there is still a balance on the court after February 1, 2025, management reserves the right to assign court or courts to another group.
4. Court deposits are refunded only if/when your court is resold.
5. Court time is not transferable without the express written consent of the management.
6. No beverages (except water) or food permitted on the tennis courts.
7. Club will not be responsible for any items left in locker area or any other part of the building.
8. Proper court courtesies must be observed.
9. All players agree that the use of the facilities of club shall be used at their own risk and they shall hold the club harmless from any liability of any kind including personal injury in connection with the use of the entire facility.
10. There will be a charge of \$8.00 per hour per child for babysitting when the service is requested.
11. Carefree reserves the right to cancel or reschedule court assignments at any time for whatever reason we deem necessary.
12. It is understood all players in the group abide by the rules and regulations of this application and those posted throughout the club.
