- 4. Court deposits are refunded only if/when your court is resold.
- 5. Court time is not transferable without the express written consent of the management.
- 6. No beverages (except water) or food permitted on the tennis courts.
- 7. Club will not be responsible for any items left in locker area or any other part of the building.
- 8. Proper court courtesies must be observed.
